# The Brezis-Browder Theorem in a general Banach space

#### Abstract

During the 1970s Brezis and Browder presented a now classical characterization of maximal monotonicity of monotone linear relations in reflexive spaces. In this paper, we extend (and refine) their result to a general Banach space. We also provide an affirmative answer to a problem posed by Phelps and Simons.

## 1 Introduction

Throughout this paper, we assume that
$X$ is a real Banach space with norm $\|\cdot\|$,
that $X^{*}$ is the continuous dual of $X$, and that $X$ and $X^{*}$ are paired by $\langle\cdot, \cdot\rangle$. The closed unit ball in $X$ is denoted by $B_{X}=\{x \in X \mid\|x\| \leq 1\}$, and $\mathbb{N}=\{1,2,3, \ldots\}$.

[^0]We identify $X$ with its canonical image in the bidual space $X^{* *}$. As always, $X \times X^{*}$ and $\left(X \times X^{*}\right)^{*}=X^{*} \times X^{* *}$ are paired via

$$
\left\langle\left(x, x^{*}\right),\left(y^{*}, y^{* *}\right)\right\rangle=\left\langle x, y^{*}\right\rangle+\left\langle x^{*}, y^{* *}\right\rangle,
$$

where $\left(x, x^{*}\right) \in X \times X^{*}$ and $\left(y^{*}, y^{* *}\right) \in X^{*} \times X^{* *}$. The norm on $X \times X^{*}$, written as $\|\cdot\|_{1}$, is defined by $\left\|\left(x, x^{*}\right)\right\|_{1}=\|x\|+\left\|x^{*}\right\|$ for every $\left(x, x^{*}\right) \in X \times X^{*}$.

Let $A: X \rightrightarrows X^{*}$ be a set-valued operator (also known as multifunction) from $X$ to $X^{*}$, i.e., for every $x \in X, A x \subseteq X^{*}$, and let gra $A=\left\{\left(x, x^{*}\right) \in X \times X^{*} \mid x^{*} \in A x\right\}$ be the graph of $A$. The domain of $A$, written as $\operatorname{dom} A$, is $\operatorname{dom} A=\{x \in X \mid A x \neq \varnothing\}$ and $\operatorname{ran} A=A(X)$ is the range of $A$. We say $A$ is a linear relation if gra $A$ is a linear subspace. By saying $A: X \rightrightarrows X^{*}$ is at most singlevalued, we mean that for every $x \in X, A x$ is either a singleton or empty. In this case, we follow a slight but common abuse of notation and write $A: \operatorname{dom} A \rightarrow X^{*}$. Conversely, if $T: D \rightarrow X^{*}$, we may identify $T$ with $A: X \rightrightarrows X^{*}$, where $A$ is at most single-valued with $\operatorname{dom} A=D$.

Now let $U \times V \subseteq X \times X^{*}$. We say that $A$ is monotone with respect to $U \times V$, if for every $\left(x, x^{*}\right) \in(\operatorname{gra} A) \cap(U \times V)$ and $\left(y, y^{*}\right) \in(\operatorname{gra} A) \cap(U \times V)$, we have

$$
\begin{equation*}
\left\langle x-y, x^{*}-y^{*}\right\rangle \geq 0 \tag{1}
\end{equation*}
$$

Of course, by (classical) monotonicity we mean monotonicity with respect to $X \times X^{*}$. Furthermore, we say that $A$ is maximally monotone with respect to $U \times V$ if $A$ is monotone with respect to $U \times V$ and for every operator $B: X \rightrightarrows X^{*}$ that is monotone with respect to $U \times V$ and such that (gra $A) \cap(U \times V) \subseteq(\operatorname{gra} B) \cap(U \times V)$, we necessarily have $(\operatorname{gra} A) \cap(U \times V)=(\operatorname{gra} B) \cap(U \times V)$. Thus, (classical) maximal monotonicity corresponds to maximal monotonicity with respect to $X \times X^{*}$. This slightly unusual presentation is required to state our main results; moreover, it yields a more concise formulation of monotone operators of type (FP).

Now let $A: X \rightrightarrows X^{*}$ be monotone and $\left(x, x^{*}\right) \in X \times X^{*}$. We say $\left(x, x^{*}\right)$ is monotonically related to gra $A$ if

$$
\left\langle x-y, x^{*}-y^{*}\right\rangle \geq 0, \quad \forall\left(y, y^{*}\right) \in \operatorname{gra} A
$$

If $Z$ is a real Banach space with continuous dual $Z^{*}$ and a subset $S$ of $Z$, we denote $S^{\perp}$ by $S^{\perp}=\left\{z^{*} \in Z^{*} \mid\left\langle z^{*}, s\right\rangle=0, \quad \forall s \in S\right\}$. Given a subset $D$ of $Z^{*}$, we define $D_{\perp}$ by $D_{\perp}=\{z \in Z \mid$ $\left.\left\langle z, d^{*}\right\rangle=0, \quad \forall d^{*} \in D\right\}=D^{\perp} \cap Z$.

The operator adjoint of $A$, written as $A^{*}$, is defined by

$$
\operatorname{gra} A^{*}=\left\{\left(x^{* *}, x^{*}\right) \in X^{* *} \times X^{*} \mid\left(x^{*},-x^{* *}\right) \in(\operatorname{gra} A)^{\perp}\right\} .
$$

Note that the adjoint is always a linear relation with gra $A^{*} \subseteq X^{* *} \times X^{*} \subseteq X^{* *} \times X^{* * *}$. These inclusions make it possible to consider monotonicity properties of $A^{*}$; however, care is required: as a linear relation, gra $A^{*} \subseteq X^{* *} \times X^{*}$ while as a potential monotone operator we are led to consider gra $A^{*} \subseteq X^{* *} \times X^{* * *}$. Now let $A: X \rightrightarrows X^{*}$ be a linear relation. We say that $A$ is skew
if gra $A \subseteq \operatorname{gra}\left(-A^{*}\right)$; equivalently, if $\left\langle x, x^{*}\right\rangle=0, \forall\left(x, x^{*}\right) \in \operatorname{gra} A$. Furthermore, $A$ is symmetric if $\operatorname{gra} A \subseteq \operatorname{gra} A^{*}$; equivalently, if $\left\langle x, y^{*}\right\rangle=\left\langle y, x^{*}\right\rangle, \forall\left(x, x^{*}\right),\left(y, y^{*}\right) \in \operatorname{gra} A$.

We now recall three fundamental subclasses of maximally monotone operators.
Definition 1.1 Let $A: X \rightrightarrows X^{*}$ be maximally monotone. The three key types of monotone operators are defined as follows.
(i) $A$ is of dense type or type (D) (1971, [23], [29] and [39, Theorem 9.5]) if for every $\left(x^{* *}, x^{*}\right) \in$ $X^{* *} \times X^{*}$ with

$$
\inf _{\left(a, a^{*}\right) \in \operatorname{gra} A}\left\langle a-x^{* *}, a^{*}-x^{*}\right\rangle \geq 0,
$$

there exist a bounded net $\left(a_{\alpha}, a_{\alpha}^{*}\right)_{\alpha \in \Gamma}$ in gra $A$ such that $\left(a_{\alpha}, a_{\alpha}^{*}\right)_{\alpha \in \Gamma}$ weak ${ }^{*} \times$ strong converges to $\left(x^{* *}, x^{*}\right)$.
(ii) $A$ is of type negative infimum (NI) (1996, [35]) if

$$
\sup _{\left(a, a^{*}\right) \in \operatorname{gra} A}\left(\left\langle a, x^{*}\right\rangle+\left\langle a^{*}, x^{* *}\right\rangle-\left\langle a, a^{*}\right\rangle\right) \geq\left\langle x^{* *}, x^{*}\right\rangle, \quad \forall\left(x^{* *}, x^{*}\right) \in X^{* *} \times X^{*} .
$$

(iii) $A$ is of type Fitzpatrick-Phelps (FP) (1992, [22]) if whenever $V$ is an open convex subset of $X^{*}$ such that $V \cap \operatorname{ran} A \neq \varnothing$, it must follow that $A$ is maximally monotone with respect to $X \times V$.

Fact 1.2 (See [36, 38, 16].) The following are maximally monotone of type (D), (NI), and (FP).
(i) $\partial f$, where $f: X \rightarrow]-\infty,+\infty]$ is convex, lower semicontinuous, and proper;
(ii) $A: X \rightrightarrows X^{*}$, where $A$ is maximally monotone and $X$ is reflexive.

These and other relationships known amongst these and other monotonicity notions are described in [16, Chapter 9]. As we see in the following result, it is a consequence of recent work that the three classes of Definition 1.1 coincide.

Fact 1.3 (See [4, Corollary 3.2] and [37, 35, 26].) Let $A: X \rightrightarrows X^{*}$ be maximally monotone. Then the following are equivalent.
(i) $A$ is of type ( $D$ ).
(ii) $A$ is of type (NI).
(iii) $A$ is of type (FP).

This is a powerful result because it is often easier to establish (ii) or (iii) than (i).
Monotone operators have proven to be a key class of objects in both modern Optimization and Analysis; see, e.g., [13, 14, 15], the books [7, 16, 20, 30, 36, 38, 33, 44, 45, 46] and the references therein.

Let us now precisely state the aforementioned Brezis-Browder Theorem:
Theorem 1.4 (Brezis-Browder in reflexive Banach space [18, 19]) Suppose that $X$ is reflexive. Let $A: X \rightrightarrows X^{*}$ be a monotone linear relation such that gra $A$ is closed. Then $A$ is maximally monotone if and only if the adjoint $A^{*}$ is monotone.

In this paper, we generalize the Brezis-Browder Theorem to an arbitrary Banach space. (See also [40] and 41] for Simons' recent extensions in the context of symmetrically self-dual Banach (SSDB) spaces as defined in [38, §21] and of Banach SNL spaces.)

Our main result is the following.
Theorem 1.5 (Brezis-Browder in general Banach space) Let $A: X \rightrightarrows X^{*}$ be a monotone linear relation such that gra $A$ is closed. Then $A$ is maximally monotone of type ( $D$ ) if and only if $A^{*}$ is monotone.

This result will also give an affirmative answer to a question posed by Phelps and Simons in [31, Section 9, item 2]:

Let $A: \operatorname{dom} A \rightarrow X^{*}$ be linear and maximally monotone. Assume that $A^{*}$ is monotone. Is A necessarily of type ( $D$ )?

The paper is organized as follows. In Section 2, we collect auxiliary results for future reference and for the reader's convenience. In Section 3, we provide the key technical step leading us to show that when $A^{*}$ is monotone then $A$ is of type (D). Our central result, the generalized Brezis-Browder Theorem (Theorem 1.5), is then proved in Section 4 . Finally, in Section 5 with the necessary proviso that the domain be closed, we establish further results such as Theorem 5.5 relating to the skew part of the operator. This was motivated by and extends [2, Theorem 4.1] which studied the case of a bounded linear operator.

Finally, let us mention that we adopt standard convex analysis notation. Given a subset $C$ of $X, \operatorname{int} C$ is the interior of $C, \bar{C}$ is the norm closure of $C$. For the set $D \subseteq X^{*}, \bar{D}^{\mathrm{w}^{*}}$ is the weak* closure of $D$. If $E \subseteq X^{* *}, \bar{E}^{\mathrm{w}^{*}}$ is the weak ${ }^{*}$ closure of $E$ in $X^{* *}$ with the topology induced by $X^{*}$. The indicator function of $C$, written as $\iota_{C}$, is defined at $x \in X$ by

$$
\iota_{C}(x)= \begin{cases}0, & \text { if } x \in C  \tag{2}\\ +\infty, & \text { otherwise }\end{cases}
$$

For every $x \in X$, the normal cone operator of $C$ at $x$ is defined by $N_{C}(x)=\left\{x^{*} \in X^{*} \mid\right.$ $\left.\sup _{c \in C}\left\langle c-x, x^{*}\right\rangle \leq 0\right\}$, if $x \in C$; and $N_{C}(x)=\varnothing$, if $x \notin C$.

Let $f: X \rightarrow]-\infty,+\infty]$. Then $\operatorname{dom} f=f^{-1}(\mathbb{R})$ is the domain of $f$, and $f^{*}: X^{*} \rightarrow$ $[-\infty,+\infty]: x^{*} \mapsto \sup _{x \in X}\left(\left\langle x, x^{*}\right\rangle-f(x)\right)$ is the Fenchel conjugate of $f$. The lower semicontinuous hull of $f$ is denoted by $\bar{f}$. We say $f$ is proper if $\operatorname{dom} f \neq \varnothing$. Let $f$ be proper. The subdifferential of $f$ is defined by

$$
\partial f: X \rightrightarrows X^{*}: x \mapsto\left\{x^{*} \in X^{*} \mid(\forall y \in X)\left\langle y-x, x^{*}\right\rangle+f(x) \leq f(y)\right\}
$$

For $\varepsilon \geq 0$, the $\varepsilon$-subdifferential of $f$ is defined by $\partial_{\varepsilon} f: X \rightrightarrows X^{*}: x \mapsto\left\{x^{*} \in X^{*} \mid\right.$ $\left.(\forall y \in X)\left\langle y-x, x^{*}\right\rangle+f(x) \leq f(y)+\varepsilon\right\}$. Note that $\partial f=\partial_{0} f$.

Let $\left.\left.F: X \times X^{*} \rightarrow\right]-\infty,+\infty\right]$. We say $F$ is a representative of the monotone operator $A: X \rightrightarrows$ $X^{*}$ if $F$ is proper, lower semicontinuous and convex with $F \geq\langle\cdot, \cdot\rangle$ on $X \times X^{*}$ and

$$
\operatorname{gra} A=\left\{\left(x, x^{*}\right) \in X \times X^{*} \mid F\left(x, x^{*}\right)=\left\langle x, x^{*}\right\rangle\right\} .
$$

Let $\left(z, z^{*}\right) \in X \times X^{*}$ and $\left.\left.F: X \times X^{*} \rightarrow\right]-\infty,+\infty\right]$. Then $\left.F_{\left(z, z^{*}\right)}: X \times X^{*} \rightarrow\right]-\infty,+\infty$ ] [27, 38] is defined by

$$
\begin{align*}
F_{\left(z, z^{*}\right)}\left(x, x^{*}\right) & =F\left(z+x, z^{*}+x^{*}\right)-\left(\left\langle x, z^{*}\right\rangle+\left\langle z, x^{*}\right\rangle+\left\langle z, z^{*}\right\rangle\right) \\
& =F\left(z+x, z^{*}+x^{*}\right)-\left\langle z+x, z^{*}+x^{*}\right\rangle+\left\langle x, x^{*}\right\rangle, \quad \forall\left(x, x^{*}\right) \in X \times X^{*} . \tag{3}
\end{align*}
$$

Let now $Y$ be another real Banach space. We set $P_{X}: X \times Y \rightarrow X:(x, y) \mapsto x$. Let $F_{1}, F_{2}: X \times Y \rightarrow$ $]-\infty,+\infty]$. Then the partial inf-convolution $F_{1} \square_{2} F_{2}$ is the function defined on $X \times Y$ by

$$
F_{1} \square_{2} F_{2}:(x, y) \mapsto \inf _{v \in Y}\left[F_{1}(x, y-v)+F_{2}(x, v)\right] .
$$

## 2 Prerequisite results

In this section, we gather some facts and auxiliary results used in the sequel.
Fact 2.1 (See [28, Proposition 2.6.6(c)] or [34, Theorem 4.7 and Theorem 3.12].) Let $C$ be $a$ subspace of $X$, and $D$ be a subspace of $X^{*}$. Then

$$
\left(C^{\perp}\right)_{\perp}=\bar{C} \quad \text { and } \quad\left(D_{\perp}\right)^{\perp}=\bar{D}^{\mathbf{w}^{*}}
$$

Fact 2.2 (Rockafellar) (See [32, Theorem 3)], [38, Corollary 10.3 and Theorem 18.1] or [44, Theorem 2.8.7(iii)].) Let $f, g: X \rightarrow]-\infty,+\infty]$ be proper convex functions. Assume that there exists a point $x_{0} \in \operatorname{dom} f \cap \operatorname{dom} g$ such that $g$ is continuous at $x_{0}$. Then

$$
\begin{aligned}
(f+g)^{*}\left(x^{*}\right) & =\min _{y^{*} \in X^{*}}\left[f^{*}\left(y^{*}\right)+g^{*}\left(x^{*}-y^{*}\right)\right], \quad \forall x^{*} \in X^{*} \\
\partial(f+g) & =\partial f+\partial g .
\end{aligned}
$$

Fact 2.3 (Borwein) (See [11, Theorem 1] or [44, Theorem 3.1.1].) Let $f: X \rightarrow$ ] $\infty,+\infty$ ] be a proper lower semicontinuous and convex function. Let $\varepsilon>0$ and $\beta \geq 0$ (where $\frac{1}{0}=\infty$ ). Assume that $x_{0} \in \operatorname{dom} f$ and $x_{0}^{*} \in \partial_{\varepsilon} f\left(x_{0}\right)$. There exist $x_{\varepsilon} \in X, x_{\varepsilon}^{*} \in X^{*}$ such that

$$
\begin{aligned}
& \left\|x_{\varepsilon}-x_{0}\right\|+\beta\left|\left\langle x_{\varepsilon}-x_{0}, x_{0}^{*}\right\rangle\right| \leq \sqrt{\varepsilon}, \quad x_{\varepsilon}^{*} \in \partial f\left(x_{\varepsilon}\right), \\
& \left\|x_{\varepsilon}^{*}-x_{0}^{*}\right\| \leq \sqrt{\varepsilon}\left(1+\beta\left\|x_{0}^{*}\right\|\right), \quad\left|\left\langle x_{\varepsilon}-x_{0}, x_{\varepsilon}^{*}\right\rangle\right| \leq \varepsilon+\frac{\sqrt{\varepsilon}}{\beta} .
\end{aligned}
$$

Fact 2.4 (Attouch-Brezis) (See [1, Theorem 1.1] or [38, Remark 15.2].) Let $f, g: X \rightarrow$ ] $-\infty,+\infty$ ] be proper lower semicontinuous and convex. Assume that $\bigcup_{\lambda>0} \lambda[\operatorname{dom} f-\operatorname{dom} g]$ is a closed subspace of $X$. Then

$$
(f+g)^{*}\left(z^{*}\right)=\min _{y^{*} \in X^{*}}\left[f^{*}\left(y^{*}\right)+g^{*}\left(z^{*}-y^{*}\right)\right], \quad \forall z^{*} \in X^{*} .
$$

Fact 2.5 (Simons and Zălinescu) (See [42, Theorem 4.2] or [38, Theorem 16.4(a)].) Let $Y$ be $a$ real Banach space and $\left.\left.F_{1}, F_{2}: X \times Y \rightarrow\right]-\infty,+\infty\right]$ be proper, lower semicontinuous, and convex. Assume that for every $(x, y) \in X \times Y$,

$$
\left(F_{1} \square_{2} F_{2}\right)(x, y)>-\infty
$$

and that $\bigcup_{\lambda>0} \lambda\left[P_{X} \operatorname{dom} F_{1}-P_{X} \operatorname{dom} F_{2}\right]$ is a closed subspace of $X$. Then for every $\left(x^{*}, y^{*}\right) \in$ $X^{*} \times Y^{*}$,

$$
\left(F_{1} \square_{2} F_{2}\right)^{*}\left(x^{*}, y^{*}\right)=\min _{u^{*} \in X^{*}}\left[F_{1}^{*}\left(x^{*}-u^{*}, y^{*}\right)+F_{2}^{*}\left(u^{*}, y^{*}\right)\right] .
$$

The following result was first established in [12, Theorem 7.4]. We next provide a new proof.
Fact 2.6 (Borwein) Let $A, B: X \rightrightarrows X^{*}$ be linear relations such that gra $A$ and gra $B$ are closed. Assume that $\operatorname{dom} A-\operatorname{dom} B$ is closed. Then

$$
(A+B)^{*}=A^{*}+B^{*} .
$$

Proof. We have

$$
\begin{equation*}
\iota_{\operatorname{gra}(A+B)}=\iota_{\operatorname{gra} A} \square_{2} \iota_{\operatorname{gra} B} . \tag{4}
\end{equation*}
$$

Let $\left(x^{* *}, x^{*}\right) \in X^{* *} \times X^{*}$. Since gra $A$ and gra $B$ are closed convex, $\iota_{\text {gra } A}$ and $\iota_{\text {gra }} B$ are proper lower semicontinuous and convex. Then by Fact 2.5 and (4), there exists $y^{*} \in X^{*}$ such that

$$
\begin{align*}
\iota_{\operatorname{gra}(A+B)^{*}\left(x^{* *}, x^{*}\right)} & =\iota_{(\operatorname{gra}(A+B))^{\perp}\left(-x^{*}, x^{* *}\right)} \\
& =\iota_{\operatorname{gra}(A+B)}^{*}\left(-x^{*}, x^{* *}\right) \quad(\text { since } \operatorname{gra}(A+B) \text { is a subspace }) \\
& =\iota_{\operatorname{gra} A}^{*}\left(y^{*}, x^{* *}\right)+\iota_{\operatorname{gra} B}^{*}\left(-x^{*}-y^{*}, x^{* *}\right) \\
& =\iota_{(\operatorname{gra} A)^{\perp}\left(y^{*}, x^{* *}\right)+\iota_{(\operatorname{gra} B)^{\perp}\left(-x^{*}-y^{*}, x^{* *}\right)}}=\iota_{\operatorname{gra} A^{*}\left(x^{* *},-y^{*}\right)+\iota_{\operatorname{gra} B^{*}}\left(x^{* *}, x^{*}+y^{*}\right)} \\
& =\iota_{\operatorname{gra}\left(A^{*}+B^{*}\right)}\left(x^{* *}, x^{*}\right) .
\end{align*}
$$

Then we have $\operatorname{gra}(A+B)^{*}=\operatorname{gra}\left(A^{*}+B^{*}\right)$ and hence $(A+B)^{*}=A^{*}+B^{*}$.

Fact 2.7 (Simons) (See [38, Lemma 19.7 and Section 22].) Let $A: X \rightrightarrows X^{*}$ be a monotone operator such that gra $A$ is convex with gra $A \neq \varnothing$. Then the function

$$
\begin{equation*}
\left.\left.g: X \times X^{*} \rightarrow\right]-\infty,+\infty\right]:\left(x, x^{*}\right) \mapsto\left\langle x, x^{*}\right\rangle+\iota_{\operatorname{gra} A}\left(x, x^{*}\right) \tag{6}
\end{equation*}
$$

is proper and convex.
Fact 2.8 (Marques Alves and Svaiter) (See [26, Theorem 4.4].) Let A: $X \rightrightarrows X^{*}$ be maximally monotone, and let $F: X \rightarrow]-\infty,+\infty]$ be a representative of $A$. Then $A$ is of type ( $D$ ) if and only if for every $\left(x_{0}, x_{0}^{*}\right) \in X \times X^{*}$,

$$
\inf _{\left(x, x^{*}\right) \in X \times X^{*}}\left[F_{\left(x_{0}, x_{0}^{*}\right)}\left(x, x^{*}\right)+\frac{1}{2}\|x\|^{2}+\frac{1}{2}\left\|x^{*}\right\|^{2}\right]=0 .
$$

We also recall the following somewhat more precise version of Theorem 1.4 ,
Fact 2.9 (Brezis and Browder) (See [19, Theorem 2], or [17, 18, 40, 43].) Suppose that $X$ is reflexive. Let $A: X \rightrightarrows X^{*}$ be a monotone linear relation such that gra $A$ is closed. Then the following are equivalent.
(i) $A$ is maximally monotone.
(ii) $A^{*}$ is maximally monotone.
(iii) $A^{*}$ is monotone.

Now let us cite some basic properties of linear relations.
The following result appeared in Cross' book [21]. We give new proofs of items (iv) (vi). The proof of item (vi) below was adapted from [10, Remark 2.2].

Fact 2.10 Let $A: X \rightrightarrows X^{*}$ be a linear relation. Then the following hold.
(i) $A x=x^{*}+A 0, \quad \forall x^{*} \in A x$.
(ii) $A(\alpha x+\beta y)=\alpha A x+\beta A y, \forall(\alpha, \beta) \in \mathbb{R}^{2} \backslash\{(0,0)\}, \forall x, y \in \operatorname{dom} A$.
(iii) $\left\langle A^{*} x, y\right\rangle=\langle x, A y\rangle$ is a singleton, $\forall x \in \operatorname{dom} A^{*}, \forall y \in \operatorname{dom} A$.
(iv) $(\operatorname{dom} A)^{\perp}=A^{*} 0$ is $\left.(\text { weak })^{*}\right)$ closed and $\overline{\operatorname{dom} A}=\left(A^{*} 0\right)_{\perp}$.
(v) If gra $A$ is closed, then $\left(\operatorname{dom} A^{*}\right)_{\perp}=A 0$ and $\overline{\operatorname{dom} A^{*}}{ }^{\mathrm{w}^{*}}=(A 0)^{\perp}$.
(vi) If $\operatorname{dom} A$ is closed, then $\operatorname{dom} A^{*}=(\bar{A} 0)^{\perp}$ and thus $\operatorname{dom} A^{*}$ is (weak*) closed, where $\bar{A}$ is the linear relation whose graph is the closure of the graph of $A$.

Proof. (i): See [21, Proposition I.2.8(a)]. (ii)\} See [21, Corollary I.2.5]. (iii), See [21, Proposition III.1.2].
(iv): We have

## 3 A key result

The proof of Proposition 3.1] was in part inspired by that of [46, Theorem 32.L] and by that of [25, Theorem 2.1].

Proposition 3.1 Let $A: X \rightrightarrows X^{*}$ be a monotone linear relation such that gra $A$ is closed and $A^{*}$ is monotone. Define

Proposition 3.2 Let $A: X \rightrightarrows X^{*}$ be a monotone linear relation such that gra $A$ is closed and $A^{*}$ is monotone. Then $A$ is maximally monotone of type ( $D$ ).

Proof. By Fact 2.8 and Proposition 3.1, it suffices to show that $A$ is maximally monotone. Let $\left(z, z^{*}\right) \in X \times X^{*}$. Assume that

$$
\begin{equation*}
\left(z, z^{*}\right) \text { is monotonically related to gra } A \text {. } \tag{28}
\end{equation*}
$$

Define

$$
\left.\left.F: X \times X^{*} \rightarrow\right]-\infty,+\infty\right]:\left(x, x^{*}\right) \mapsto \iota_{\operatorname{gra} A}\left(x, x^{*}\right)+\left\langle x, x^{*}\right\rangle .
$$

We have

$$
\begin{equation*}
F_{\left(z, z^{*}\right)}:\left(x, x^{*}\right) \mapsto \iota_{\operatorname{gra} A}\left(z+x, z^{*}+x^{*}\right)+\left\langle x, x^{*}\right\rangle . \tag{29}
\end{equation*}
$$

Proposition 3.1 implies that there exists a sequence $\left(x_{n}, x_{n}^{*}\right)_{n \in \mathbb{N}}$ in $\operatorname{dom} F_{\left(z, z^{*}\right)}$ such that

$$
\begin{equation*}
F_{\left(z, z^{*}\right)}\left(x_{n}, x_{n}^{*}\right)+\frac{1}{2}\left\|x_{n}\right\|^{2}+\frac{1}{2}\left\|x_{n}^{*}\right\|^{2} \rightarrow 0 \tag{30}
\end{equation*}
$$

Set $\left(a_{n}, a_{n}^{*}\right):=\left(z+x_{n}, z^{*}+x_{n}^{*}\right), \quad \forall n \in \mathbb{N}$. Then by (29), we have

$$
\begin{align*}
F_{\left(z, z^{*}\right)}\left(x_{n}, x_{n}^{*}\right) & =\iota_{\text {gra } A}\left(z+x_{n}, z^{*}+x_{n}^{*}\right)+\left\langle x_{n}, x_{n}^{*}\right\rangle  \tag{31}\\
& =\iota_{\text {gra } A}\left(a_{n}, a_{n}^{*}\right)+\left\langle a_{n}-z, a_{n}^{*}-z^{*}\right\rangle . \tag{32}
\end{align*}
$$

By (30) and (32),

$$
\begin{equation*}
\left(a_{n}, a_{n}^{*}\right) \in \operatorname{gra} A, \quad \forall n \in \mathbb{N} . \tag{33}
\end{equation*}
$$

Then by (33) and (28), we have

$$
\begin{equation*}
\left\langle x_{n}, x_{n}^{*}\right\rangle=\left\langle a_{n}-z, a_{n}^{*}-z^{*}\right\rangle \geq 0, \quad \forall n \in \mathbb{N} . \tag{34}
\end{equation*}
$$

Combining (32) and (34),

$$
\begin{equation*}
F_{\left(z, z^{*}\right)}\left(x_{n}, x_{n}^{*}\right) \geq 0, \quad \forall n \in \mathbb{N} . \tag{35}
\end{equation*}
$$

In view of (35) and (30),

$$
\begin{equation*}
\left\|x_{n}\right\|^{2}+\left\|x_{n}^{*}\right\|^{2} \rightarrow 0 \tag{36}
\end{equation*}
$$

Thus $\left(x_{n}, x_{n}^{*}\right) \rightarrow(0,0)$ and hence $\left(a_{n}, a_{n}^{*}\right) \rightarrow\left(z, z^{*}\right)$. Finally, by 33) and since gra $A$ is closed, we see $\left(z, z^{*}\right) \in \operatorname{gra} A$. Therefore, $A$ is maximally monotone.

Remark 3.3 Proposition 3.2 provides an affirmative answer to a problem posed by Phelps and Simons in [31, Section 9, item 2] on the converse of [31, Theorem 6.7(c) $\Rightarrow$ (f)]. In [6, Proposition 3.1], we present an alternative proof for Proposition 3.2.

Example 3.4 Let $A: X \rightrightarrows X^{*}$ be a monotone linear relation such that gra $A$ is closed. We note that we cannot guarantee the maximal monotonicity of $A$ even if $A$ is at most single-valued and densely defined. To see this, suppose that $X=\ell^{2}$, and that $A: \ell^{2} \rightrightarrows \ell^{2}$ is given by

$$
\begin{equation*}
A x:=\frac{\left(\sum_{i<n} x_{i}-\sum_{i>n} x_{i}\right)_{n \in \mathbb{N}}}{2}=\left(\sum_{i<n} x_{i}+\frac{1}{2} x_{n}\right)_{n \in \mathbb{N}}, \quad \forall x=\left(x_{n}\right)_{n \in \mathbb{N}} \in \operatorname{dom} A, \tag{37}
\end{equation*}
$$

where $\operatorname{dom} A:=\left\{x:=\left(x_{n}\right)_{n \in \mathbb{N}} \in \ell^{2} \mid \sum_{i \geq 1} x_{i}=0,\left(\sum_{i \leq n} x_{i}\right)_{n \in \mathbb{N}} \in \ell^{2}\right\}$. Then $A$ is an at most single-valued linear relation. Now [9, Propositions 3.6] states that

$$
\begin{equation*}
A^{*} x=\left(\frac{1}{2} x_{n}+\sum_{i>n} x_{i}\right)_{n \in \mathbb{N}}, \tag{38}
\end{equation*}
$$

where

$$
x=\left(x_{n}\right)_{n \in \mathbb{N}} \in \operatorname{dom} A^{*}=\left\{x=\left(x_{n}\right)_{n \in \mathbb{N}} \in \ell^{2} \mid\left(\sum_{i>n} x_{i}\right)_{n \in \mathbb{N}} \in \ell^{2}\right\} .
$$

Moreover, [9, Propositions 3.2, 3.5, 3.6 and 3.8], [31, Theorem 2.5] and Fact 2.9 show that:
(i) $A$ is maximally monotone and skew;
(ii) $\operatorname{dom} A$ is dense and $\operatorname{dom} A \varsubsetneqq \operatorname{dom} A^{*}$;
(iii) $A^{*}$ is maximally monotone, but not skew;
(iv) $-A$ is not maximally monotone.

Hence, $-A$ is monotone with dense domain and $\operatorname{gra}(-A)$ is closed, but nonetheless $-A$ is not maximally monotone.

## 4 The general Brezis-Browder theorem

We may now pack everything together to establish our central result. For the reader's convenience we repeat Theorem 1.5 ;

Theorem 4.1 (Brezis-Browder in general Banach space) Let $A: X \rightrightarrows X^{*}$ be a monotone linear relation such that gra $A$ is closed. Then $A$ is maximally monotone of type ( $D$ ) if and only if $A^{*}$ is monotone.

Proof. " $\Rightarrow$ ": By Fact $1.3, A$ is of type (NI). Suppose to the contrary that there exists $\left(a_{0}^{* *}, a_{0}^{*}\right) \in$ $\operatorname{gra} A^{*}$ such that $\left\langle a_{0}^{* *}, a_{0}^{*}\right\rangle<0$. Then we have

$$
\sup _{\left(a, a^{*}\right) \in \operatorname{gra} A}\left(\left\langle a,-a_{0}^{*}\right\rangle+\left\langle a_{0}^{* *}, a^{*}\right\rangle-\left\langle a, a^{*}\right\rangle\right)=\sup _{\left(a, a^{*}\right) \in \operatorname{gra} A}\left\{-\left\langle a, a^{*}\right\rangle\right\}=0<\left\langle-a_{0}^{* *}, a_{0}^{*}\right\rangle,
$$

which contradicts that $A$ is type of (NI). Hence $A^{*}$ is monotone.
$" \Leftarrow$ ": Apply Proposition 3.2 directly.
Remark 4.2 The proof of the necessary part in Theorem 4.1 follows closely that of [19, Theorem 2].

The original Brezis and Browder result follows.
Corollary 4.3 (Brezis and Browder) Suppose that $X$ is reflexive. Let $A: X \rightrightarrows X^{*}$ be a monotone linear relation such that gra $A$ is closed. Then the following are equivalent.
(i) $A$ is maximally monotone.
(ii) $A^{*}$ is maximally monotone.
(iii) $A^{*}$ is monotone.

Proof. ‘(i) $\Rightarrow$ (iii)': Apply Theorem 4.1 and Fact 1.2 directly.
‘(ii) $\Rightarrow$ (iii)' : Clear.
'(iii) $\Rightarrow$ (ii)]': Since gra $A$ is closed, $\left(A^{*}\right)^{*}=A$. Apply Theorem 4.1 to $A^{*}$.

In the case of a skew operator we can add maximality of the adjoint and so we prefigure results of the next section:

Corollary 4.4 (The skew case) Let $A: X \rightrightarrows X^{*}$ be a skew operator such that gra $A$ is closed. Then the following are equivalent.
(i) $A$ is maximally monotone of type ( $D$ ).
(ii) $A^{*}$ is monotone.
(iii) $A^{*}$ is maximally monotone with respect to $X^{* *} \times X^{*}$.

Proof. By Theorem 4.1, it only remains to show
‘(ii) $\Rightarrow$ (iii)': Let $\left(z^{* *}, z^{*}\right) \in X^{* *} \times X^{*}$ be monotonically related to gra $A^{*}$. Since $\operatorname{gra}(-A) \subseteq$ $\operatorname{gra} A^{*},\left(z^{* *}, z^{*}\right)$ is monotonically related to $\operatorname{gra}(-A)$. Thus $\left(z^{*}, z^{* *}\right) \in[\operatorname{gra}(-A)]^{\perp}$ since $\operatorname{gra} A$ is linear. Hence $\left(z^{* *}, z^{*}\right) \in \operatorname{gra} A^{*}$. Hence $A^{*}$ is maximally monotone.

Remark 4.5 We cannot say $A^{*}$ is maximally monotone with respect to $X^{* *} \times X^{* * *}$ in Corollary 4.4|(iii). indeed, let $A$ be defined by

$$
\operatorname{gra} A=\{0\} \times X^{*}
$$

Then gra $A^{*}=\{0\} \times X^{*}$. If $X$ is not reflexive, then $X^{*} \varsubsetneqq X^{* * *}$ and so gra $A^{*}$ is a proper subset of $\{0\} \times X^{* * *}$. Hence $A^{*}$ is not maximally monotone with respect to $X^{* *} \times X^{* * *}$ although $A$ is maximally monotone of type (D) (since $A=N_{\{0\}}$ by Fact 1.2. .

We conclude with an application of Theorem 4.1 to an operator studied previously by Phelps and Simons 31 .

Example 4.6 Suppose that $X=L^{1}[0,1]$ so that $X^{*}=L^{\infty}[0,1]$, let

$$
D=\left\{x \in X \mid x \text { is absolutely continuous, } x(0)=0, x^{\prime} \in X^{*}\right\},
$$

and set

$$
A: X \rightrightarrows X^{*}: x \mapsto \begin{cases}\left\{x^{\prime}\right\}, & \text { if } x \in D \\ \varnothing, & \text { otherwise }\end{cases}
$$

By [31, Example 4.3], $A$ is an at most single-valued maximally monotone linear relation with proper dense domain, and $A$ is neither symmetric nor skew. Moreover,

$$
\operatorname{dom} A^{*}=\left\{z \in X^{* *} \mid z \text { is absolutely continuous, } z(1)=0, z^{\prime} \in X^{*}\right\} \subseteq X
$$

$A^{*} z=-z^{\prime}, \forall z \in \operatorname{dom} A^{*}$, and $A^{*}$ is monotone. Therefore, Theorem 4.1 implies that $A$ is of type (D).

In the next section, we turn to the question of how the skew part of the adjoint behaves.

## 5 Decomposition of monotone linear relations

In this section, our main result states that $A$ is maximally monotone of type (D) if and only if its skew part $A_{\circ}$ is maximally monotone of type (D) and $A^{*} 0=A 0$. When $\operatorname{dom} A$ is closed, we also obtained a refined version of the Brezis-Browder Theorem.

Let us first gather some basic properties about monotone linear relations, and conditions for them to be maximally monotone.

The next three propositions were proven in reflexive spaces in [8, Proposition 2.2]. We adjust the proofs to a general Banach space setting.

Proposition 5.1 (Monotone linear relations) Let $A: X \rightrightarrows X^{*}$ be a linear relation. Then the following hold.
(i) Suppose $A$ is monotone. Then $\operatorname{dom} A \subseteq(A 0)_{\perp}$ and $A 0 \subseteq(\operatorname{dom} A)^{\perp}$; consequently, if gra $A$ is closed, then $\operatorname{dom} A \subseteq \overline{\operatorname{dom} A^{*}}{ }^{\mathrm{w}^{*}} \cap X$ and $A 0 \subseteq A^{*} 0$.
(ii) $(\forall x \in \operatorname{dom} A)\left(\forall z \in(A 0)_{\perp}\right)\langle z, A x\rangle$ is single-valued.
(iii) $\left(\forall z \in(A 0)_{\perp}\right) \operatorname{dom} A \rightarrow \mathbb{R}: y \mapsto\langle z, A y\rangle$ is linear.
(iv) If $A$ is monotone, then $(\forall x \in \operatorname{dom} A)\langle x, A x\rangle$ is single-valued.
(v) $A$ is monotone $\Leftrightarrow(\forall x \in \operatorname{dom} A) \inf \langle x, A x\rangle \geq 0$.
(vi) If $\left(x, x^{*}\right) \in(\operatorname{dom} A) \times X^{*}$ is monotonically related to gra $A$ and $x_{0}^{*} \in A x$, then $x^{*}-x_{0}^{*} \in$ $(\operatorname{dom} A)^{\perp}$.

Proof. [(i)] Pick $x \in \operatorname{dom} A$. Then there exists $x^{*} \in X^{*}$ such that $\left(x, x^{*}\right) \in \operatorname{gra} A$. By monotonicity of $A$ and since $\{0\} \times A 0 \subseteq$ gra $A$, we have $\left\langle x, x^{*}\right\rangle \geq \sup \langle x, A 0\rangle$. Since $A 0$ is a linear subspace, we obtain $x \perp A 0$. This implies $\operatorname{dom} A \subseteq(A 0)_{\perp}$ and $A 0 \subseteq(\operatorname{dom} A)^{\perp}$. If gra $A$ is closed, then Fact 2.1प(v) $火$ (iv) yields $\operatorname{dom} A \subseteq(A 0)_{\perp} \subseteq(A 0)^{\perp}=\overline{\operatorname{dom} A^{*}}{ }^{\text {w}}$ and $A 0 \subseteq A^{*} 0$.
(ii): Take $x \in \operatorname{dom} A, x^{*} \in A x$, and $z \in(A 0)_{\perp}$. By Fact 2.1q(i), $\langle z, A x\rangle=\left\langle z, x^{*}+A 0\right\rangle=\left\langle z, x^{*}\right\rangle$.
(iii): Take $z \in(A 0)_{\perp} . \operatorname{By}$ (ii), $(\forall y \in \operatorname{dom} A)\langle z, A y\rangle$ is single-valued. Now let $x, y$ be in $\operatorname{dom} A$, and let $\alpha, \beta$ be in $\mathbb{R}$. If $(\alpha, \beta)=(0,0)$, then $\langle z, A(\alpha x+\beta y)\rangle=\langle z, A 0\rangle=0=\alpha\langle z, A x\rangle+\beta\langle z, A y\rangle$. And if $(\alpha, \beta) \neq(0,0)$, then Fact 2.1प|(ii) yields $\langle z, A(\alpha x+\beta y)\rangle=\langle z, \alpha A x+\beta A y\rangle=\alpha\langle z, A x\rangle+$ $\beta\langle z, A y\rangle$. This verifies linearity.
(iv) Apply (i) (ii).
(v)] " $\Rightarrow$ ": This follows from the fact that $(0,0) \in \operatorname{gra} A$. " $\Leftarrow$ ": If $x$ and $y$ belong to dom $A$, then Fact 2.1](ii) yields $\langle x-y, A x-A y\rangle=\langle x-y, A(x-y)\rangle \geq 0$.
(vi) Let $\left(x, x^{*}\right) \in \operatorname{dom} A \times X^{*}$ be monotonically related to gra $A$, and take $x_{0}^{*} \in A x$. For every $\left(v, v^{*}\right) \in \operatorname{gra} A$, we have $x_{0}^{*}+v^{*} \in A(x+v)$ (by Fact 2.10[iii) ; hence, $\left\langle x-(x+v), x^{*}-\left(x_{0}^{*}+v^{*}\right)\right\rangle \geq 0$ and thus $\left\langle v, v^{*}\right\rangle \geq\left\langle v, x^{*}-x_{0}^{*}\right\rangle$. Now take $\lambda>0$ and replace ( $v, v^{*}$ ) in the last inequality by $\left(\lambda v, \lambda v^{*}\right)$. Then divide by $\lambda$ and let $\lambda \rightarrow 0^{+}$to see that $0 \geq \sup \left\langle\operatorname{dom} A, x^{*}-x_{0}^{*}\right\rangle$. Since $\operatorname{dom} A$ is linear, it follows that $x^{*}-x_{0}^{*} \in(\operatorname{dom} A)^{\perp}$.

We define the symmetric part and the skew part of $A$ via

$$
\begin{equation*}
A_{+}:=\frac{1}{2} A+\frac{1}{2} A^{*} \quad \text { and } \quad A_{\circ}:=\frac{1}{2} A-\frac{1}{2} A^{*} \tag{39}
\end{equation*}
$$

respectively. It is easy to check that $A_{+}$is symmetric and that $A_{\circ}$ is skew.
Proposition 5.2 (Maximally monotone linear relations) Let $A: X \rightrightarrows X^{*}$ be a monotone linear relation. Then the following hold.
(i) If $A$ is maximally monotone, then $(\operatorname{dom} A)^{\perp}=A 0$ and hence $\overline{\operatorname{dom} A}=(A 0)_{\perp}$.
(ii) If $\operatorname{dom} A$ is closed, then: $A$ is maximally monotone $\Leftrightarrow(\operatorname{dom} A)^{\perp}=A 0$.
(iii) If $A$ is maximally monotone, then $\overline{\operatorname{dom} A^{*}}{ }^{w^{*}} \cap X=\overline{\operatorname{dom} A}=(A 0)_{\perp}$, and $A 0=A^{*} 0=A_{+} 0=$ $A_{\circ} 0=(\operatorname{dom} A)^{\perp}$ is $\left.(\text { weak })^{*}\right)$ closed.
(iv) If $A$ is maximally monotone and $\operatorname{dom} A$ is closed, then $\operatorname{dom} A^{*} \cap X=\operatorname{dom} A$.
(v) If $A$ is maximally monotone and $\operatorname{dom} A \subseteq \operatorname{dom} A^{*}$, then $A=A_{+}+A_{\circ}, A_{+}=A-A_{\circ}$, and $A_{\circ}=A-A_{+}$.
(vi) If $A$ is maximally monotone and $\operatorname{dom} A$ is closed, then both $A_{+}$and $A_{\circ}$ are maximally monotone.
(vii) If $A$ is maximally monotone and dom $A$ is closed, then $A^{*}=\left(A_{+}\right)^{*}+\left(A_{\circ}\right)^{*}$.

Proof. (i): Since $A+N_{\operatorname{dom} A}=A+(\operatorname{dom} A)^{\perp}$ is a monotone extension of $A$ and $A$ is maximally monotone, we must have $A+(\operatorname{dom} A)^{\perp}=A$. Then $A 0+(\operatorname{dom} A)^{\perp}=A 0$. As $0 \in A 0,(\operatorname{dom} A)^{\perp} \subseteq$ $A 0$. Combining with Proposition 5.1)(i), we have $(\operatorname{dom} A)^{\perp}=A 0$. By Fact 2.1, $\overline{\operatorname{dom} A}=(A 0)_{\perp}$.
(ii)] " $\Rightarrow$ ": Clear from (i), " $\Leftarrow "$ : The assumptions and Fact 2.1 imply that $\operatorname{dom} A=\overline{\operatorname{dom} A}=$ $\left[(\operatorname{dom} A)^{\perp}\right]_{\perp}=(A 0)_{\perp}$. Let $\left(x, x^{*}\right)$ be monotonically related to gra $A$. We have inf $\left\langle x-0, x^{*}-A 0\right\rangle \geq$ 0 . Then we have $x \in(A 0)_{\perp}$ and hence $x \in \operatorname{dom} A$. Then by Proposition 5.1](vi) and Fact 2.10 (i), $x^{*} \in A x$. Hence $A$ is maximally monotone.
(iii): By (i) and Fact 2.1q(iv), $A 0=(\operatorname{dom} A)^{\perp}=A^{*} 0$ is weak ${ }^{*}$ closed and thus $A_{+} 0=A_{\circ} 0=$ $A 0=(\operatorname{dom} A)^{\perp}$. Then by Fact 2.10 (v) and (i), $\overline{\operatorname{dom} A^{*}}{ }^{\mathrm{w}} \cap X=(A 0)_{\perp}=\overline{\operatorname{dom} A}$.

## (iv) Combine (iii) with Fact 2.1 (vi),

(v): We show only the proof of $A=A_{+}+A_{\circ}$ as the other two proofs are analogous. Clearly, $\operatorname{dom} A_{+}=\operatorname{dom} A_{\circ}=\operatorname{dom} A \cap \operatorname{dom} A^{*}=\operatorname{dom} A$. Let $x \in \operatorname{dom} A$, and $x^{*} \in A x$ and $y^{*} \in A^{*} x$.

We write $x^{*}=\frac{x^{*}+y^{*}}{2}+\frac{x^{*}-y^{*}}{2} \in\left(A_{+}+A_{\circ}\right) x$. Then, by (iii) and Fact 2.10 (i), $A x=x^{*}+A 0=$ $x^{*}+\left(A_{+}+A_{\circ}\right) 0=\left(A_{+}+A_{\circ}\right) x$. Therefore, $A=A_{+}+A_{\circ}$.
(vi). By (iv),

$$
\begin{equation*}
\operatorname{dom} A_{+}=\operatorname{dom} A_{\circ}=\operatorname{dom} A \text { is closed. } \tag{40}
\end{equation*}
$$

Hence, by (iii),

$$
\begin{equation*}
A \circ 0=A_{+} 0=A 0=(\operatorname{dom} A)^{\perp}=\left(\operatorname{dom} A_{+}\right)^{\perp}=\left(\operatorname{dom} A_{\circ}\right)^{\perp} . \tag{41}
\end{equation*}
$$

Since $A$ is monotone, so are $A_{+}$and $A_{\circ}$. Combining (40), (41), and (ii), we deduce that $A_{+}$and $A_{\circ}$ are maximally monotone.
(vii): By (iv) (v),

$$
\begin{equation*}
A=A_{+}+A_{\circ} . \tag{42}
\end{equation*}
$$

Then by (vi), (iv), and Fact 2.6, $A^{*}=\left(A_{+}\right)^{*}+\left(A_{\circ}\right)^{*}$.
For a monotone linear relation $A: X \rightrightarrows X^{*}$ it will be convenient to define - as in, e.g., [3] - a generalized quadratic form

$$
(\forall x \in X) \quad q_{A}(x)= \begin{cases}\frac{1}{2}\langle x, A x\rangle, & \text { if } x \in \operatorname{dom} A ; \\ +\infty, & \text { otherwise }\end{cases}
$$

We write $\overline{q_{A}}$ for the lower semicontinuous hull of $q_{A}$.
Proposition 5.3 Let $A: X \rightrightarrows X^{*}$ be a monotone linear relation, let $x$ and $y$ be in $\operatorname{dom} A$, and let $\lambda \in \mathbb{R}$. Then $q_{A}$ is single-valued, $q_{A} \geq 0$ and

$$
\begin{align*}
& \lambda q_{A}(x)+(1-\lambda) q_{A}(y)-q_{A}(\lambda x+(1-\lambda) y)=\lambda(1-\lambda) q_{A}(x-y) \\
& =\frac{1}{2} \lambda(1-\lambda)\langle x-y, A x-A y\rangle . \tag{43}
\end{align*}
$$

Consequently, $q_{A}$ is convex.
Proof. Proposition 5.1|(iv) $k$ (v) show that $q_{A}$ is single-valued and that $q_{A} \geq 0$. Combining with Proposition 5.1)(i) \&(iii), we obtain (43). Therefore, $q_{A}$ is convex.

As in the classical case, $q_{A}$ allows us to connect properties of $A_{+}$to those of $A$ and $A^{*}$.
Proposition 5.4 (Properties of the symmetric part and the adjoint) Let $A: X \rightrightarrows X^{*}$ be a monotone linear relation. Then the following hold.
(i) $\overline{q_{A}}+\iota_{\operatorname{dom} A_{+}}=q_{A_{+}}$and thus $q_{A_{+}}$is convex.
(ii) gra $A_{+} \subseteq$ gra $\partial \overline{q_{A}}$. If $A_{+}$is maximally monotone, then $A_{+}=\partial \overline{q_{A}}$.
(iii) If $A$ is maximally monotone and $\operatorname{dom} A$ is closed, then $A_{+}=\partial \overline{q_{A}}$.
(iv) If $A$ is maximally monotone, then $\left.A^{*}\right|_{X}$ is monotone.
(v) If $A$ is maximally monotone and dom $A$ is closed, then $\left.A^{*}\right|_{X}$ is maximally monotone.

Proof. Let $x \in \operatorname{dom} A_{+}$.
(i) By Fact 2.1 1 (iii) and Proposition 5.1|(iv), $q_{A_{+}}=\left.q_{A}\right|_{\text {dom } A_{+}}$. Then by Proposition 5.3, $q_{A_{+}}$is convex. Let $y \in \operatorname{dom} A$. Then by Fact 2.1()(iii),

$$
\begin{equation*}
0 \leq \frac{1}{2}\langle A x-A y, x-y\rangle=\frac{1}{2}\langle A y, y\rangle+\frac{1}{2}\langle A x, x\rangle-\left\langle A_{+} x, y\right\rangle \tag{44}
\end{equation*}
$$

we have $q_{A}(y) \geq\left\langle A_{+} x, y\right\rangle-q_{A}(x)$. Take the lower semicontinuous hull of $q_{A}$ at $y$ to deduce that $\overline{q_{A}}(y) \geq\left\langle A_{+} x, y\right\rangle-q_{A}(x)$. For $y=x$, we have $\overline{q_{A}}(x) \geq q_{A}(x)$. On the other hand, $\overline{q_{A}} \leq q_{A}$. Altogether, $\overline{q_{A}}(x)=q_{A}(x)=q_{A_{+}}(x)$. Thus (i) holds.
(ii): Let $y \in \operatorname{dom} A$. By (44) and (i),

$$
\begin{equation*}
q_{A}(y) \geq q_{A}(x)+\left\langle A_{+} x, y-x\right\rangle=\overline{q_{A}}(x)+\left\langle A_{+} x, y-x\right\rangle . \tag{45}
\end{equation*}
$$

Since $\operatorname{dom} \overline{q_{A}} \subseteq \overline{\operatorname{dom} q_{A}}=\overline{\operatorname{dom} A}$, by (45), $\overline{q_{A}}(z) \geq \overline{q_{A}}(x)+\left\langle A_{+} x, z-x\right\rangle, \quad \forall z \in \operatorname{dom} \overline{q_{A}}$. Hence $A_{+} x \subseteq \partial \overline{q_{A}}(x)$. If $A_{+}$is maximally monotone, then $A_{+}=\partial \overline{q_{A}}$. Thus (ii) holds.
(iii): Combine Proposition 5.2(vi) with (ii).
(iv) Suppose to the contrary that $\left.A^{*}\right|_{X}$ is not monotone. By Proposition 5.1|(v), there exists $\left(x_{0}, x_{0}^{*}\right) \in \operatorname{gra} A^{*}$ with $x_{0} \in X$ such that $\left\langle x_{0}, x_{0}^{*}\right\rangle<0$. Now we have

$$
\begin{align*}
& \left\langle-x_{0}-y, x_{0}^{*}-y^{*}\right\rangle=-\left\langle x_{0}, x_{0}^{*}\right\rangle+\left\langle y, y^{*}\right\rangle+\left\langle x_{0}, y^{*}\right\rangle-\left\langle y, x_{0}^{*}\right\rangle \\
& =-\left\langle x_{0}, x_{0}^{*}\right\rangle+\left\langle y, y^{*}\right\rangle>0, \quad \forall\left(y, y^{*}\right) \in \operatorname{gra} A . \tag{46}
\end{align*}
$$

Thus, $\left(-x_{0}, x_{0}^{*}\right)$ is monotonically related to gra $A$. By maximal monotonicity of $A,\left(-x_{0}, x_{0}^{*}\right) \in$ $\operatorname{gra} A$. Then $\left\langle-x_{0}-\left(-x_{0}\right), x_{0}^{*}-x_{0}^{*}\right\rangle=0$, which contradicts (46). Hence $\left.A^{*}\right|_{X}$ is monotone.
(v) By Fact 2.19(vi), $\left.\operatorname{dom} A^{*}\right|_{X}=(A 0)_{\perp}$ and thus $\left.\operatorname{dom} A^{*}\right|_{X}$ is closed. By Fact 2.1 and Proposition 5.2 (i), $\left(\left.\operatorname{dom} A^{*}\right|_{X}\right)^{\perp}=\left((A 0)_{\perp}\right)^{\perp}=\overline{A 0}^{\mathrm{w}^{*}}=A 0$. Then by Proposition 5.2 (iii), (dom $\left.\left.A^{*}\right|_{X}\right)^{\perp}=A^{*} 0=\left.A^{*}\right|_{X} 0$. Applying (iv) and Proposition 5.2(ii), we see that $\left.A^{*}\right|_{X}$ is maximally monotone.

The proof of Proposition 5.4(iv) was borrowed from [19, Theorem 2]. Results very similar to Proposition 5.4|(i) \& (ii) are verified in [43, Proposition 18.9].

The proof of the next Theorem 5.5(i) $\Rightarrow$ (ii) was partially inspired by that of [2, Theorem $4.1(\mathrm{v}) \Rightarrow(\mathrm{vi})$ ]. In it we present our main findings relating monotonicity and adjoint properties of $A$ and those of its skew part $A_{\circ}$.

Theorem 5.5 (Monotone linear relations with closed graph and domain) Let $A: X \rightrightarrows$ $X^{*}$ be a monotone linear relation such that gra $A$ is closed and $\operatorname{dom} A$ is closed. Then the following are equivalent.
(i) $A$ is maximally monotone of type ( $D$ ).
(ii) $A_{\circ}$ is maximally monotone of type ( $D$ ) with respect to $X \times X^{*}$ and $A^{*} 0=A 0$.
(iii) $\left(A_{\circ}\right)^{*}$ is maximally monotone with respect to $X^{* *} \times X^{*}$ and $A^{*} 0=A 0$.
(iv) $\left(A_{\circ}\right)^{*}$ is monotone and $A^{*} 0=A 0$.
(v) $A^{*}$ is monotone.
(vi) $A^{*}$ is maximally monotone with respect to $X^{* *} \times X^{*}$.

Proof. ‘(i) $\Rightarrow($ (ii) ': By Theorem 4.1 ,

$$
\begin{equation*}
A^{*} \text { is monotone. } \tag{47}
\end{equation*}
$$

By Proposition 5.4(iii) and Fact 1.2

$$
\begin{equation*}
A_{+} \text {is maximally monotone of type (D). } \tag{48}
\end{equation*}
$$

By Theorem 4.1,

$$
\begin{equation*}
\left(A_{+}\right)^{*} \text { is monotone. } \tag{49}
\end{equation*}
$$

Now we show that

$$
\begin{equation*}
\left(A_{\circ}\right)^{*} \text { is monotone. } \tag{50}
\end{equation*}
$$

Proposition 5.2(vii) implies

$$
\begin{equation*}
A^{*}=\left(A_{+}\right)^{*}+\left(A_{\circ}\right)^{*} . \tag{51}
\end{equation*}
$$

Since $A$ is maximally monotone and $\operatorname{dom} A$ is closed, Proposition 5.2(vi) implies that $A_{\circ}$ is maximally monotone. Hence gra $\left(A_{\circ}\right)$ is closed. On the other hand, again since $A$ is maximally monotone and $\operatorname{dom} A$ is closed, Proposition 5.2(iv) yields $\operatorname{dom}\left(A_{\circ}\right)=\operatorname{dom} A$ is closed. Altogether, and combining with Fact $2.10 \mid(v i)$ applied to $A_{\circ}$, we obtain $\operatorname{dom}\left(A_{\circ}\right)^{*}=\left(A_{\circ} 0\right)^{\perp}$. Furthermore, since $A 0=A_{\circ} 0$ by Proposition 5.2 (iii), we have $(A 0)^{\perp}=\left(A_{\circ} 0\right)^{\perp}$. Moreover, applying Fact 2.10(vi) to $A$, we deduce that $\operatorname{dom} A^{*}=(A 0)^{\perp}$. Therefore,

$$
\begin{equation*}
\operatorname{dom}\left(A_{\circ}\right)^{*}=\left(A_{\circ} 0\right)^{\perp}=(A 0)^{\perp}=\operatorname{dom} A^{*} . \tag{52}
\end{equation*}
$$

Similarly, we have

$$
\begin{equation*}
\operatorname{dom}\left(A_{+}\right)^{*}=\operatorname{dom} A^{*} . \tag{53}
\end{equation*}
$$

Take $\left(x^{* *}, x^{*}\right) \in \operatorname{gra}\left(A_{\circ}\right)^{*}$. By (51) and (52), there exist $a^{*}, b^{*} \in X^{*}$ such that

$$
\begin{equation*}
\left(x^{* *}, a^{*}\right) \in \operatorname{gra} A^{*},\left(x^{* *}, b^{*}\right) \in \operatorname{gra}\left(A_{+}\right)^{*} \tag{54}
\end{equation*}
$$

and

$$
\begin{equation*}
a^{*}=b^{*}+x^{*} . \tag{55}
\end{equation*}
$$

Since $A_{+}$is symmetric, gra $A_{+} \subseteq \operatorname{gra}\left(A_{+}\right)^{*}$. Thus, by (49), $\left(x^{* *}, b^{*}\right)$ is monotonically related to gra $A_{+}$. By (48), there exist a bounded net $\left(a_{\alpha}, b_{\alpha}^{*}\right)_{\alpha \in \Gamma}$ in gra $A_{+}$such that $\left(a_{\alpha}, b_{\alpha}^{*}\right)_{\alpha \in \Gamma}$ weak ${ }^{*} \times$ strong converges to $\left(x^{* *}, b^{*}\right)$. Thus $\left(a_{\alpha}, b_{\alpha}^{*}\right) \in \operatorname{gra}\left(A_{+}\right)^{*}$. By (53) and (51), there exist $a_{\alpha}^{*} \in A^{*} a_{\alpha}, c_{\alpha}^{*} \in\left(A_{\circ}\right)^{*} a_{\alpha}$ such that

$$
\begin{equation*}
a_{\alpha}^{*}=b_{\alpha}^{*}+c_{\alpha}^{*}, \quad \forall \alpha \in \Gamma . \tag{56}
\end{equation*}
$$

Thus by Fact 2.1प(iii),

$$
\begin{equation*}
\left\langle a_{\alpha}, c_{\alpha}^{*}\right\rangle=\left\langle A_{\circ} a_{\alpha}, a_{\alpha}\right\rangle=0, \quad \forall \alpha \in \Gamma . \tag{57}
\end{equation*}
$$

Hence for every $\alpha \in \Gamma,\left(-a_{\alpha}, c_{\alpha}^{*}\right)$ is monotonically related to gra $A_{\circ}$. By Proposition 5.2(vi),

$$
\begin{equation*}
\left(-a_{\alpha}, c_{\alpha}^{*}\right) \in \operatorname{gra} A_{\circ}, \quad \forall \alpha \in \Gamma . \tag{58}
\end{equation*}
$$

By (47) and (54), we have

$$
\begin{align*}
0 & \left.\leq\left\langle x^{* *}-a_{\alpha}, a^{*}-a_{\alpha}^{*}\right\rangle=\left\langle x^{* *}-a_{\alpha}, a^{*}-b_{\alpha}^{*}-c_{\alpha}^{*}\right\rangle \quad \text { by (56) }\right) \\
& =\left\langle x^{* *}-a_{\alpha}, a^{*}-b_{\alpha}^{*}\right\rangle-\left\langle x^{* *}, c_{\alpha}^{*}\right\rangle+\left\langle a_{\alpha}, c_{\alpha}^{*}\right\rangle \\
& =\left\langle x^{* *}-a_{\alpha}, a^{*}-b_{\alpha}^{*}\right\rangle-\left\langle x^{* *}, c_{\alpha}^{*}\right\rangle \quad(\text { by (57) }) \\
& \left.=\left\langle x^{* *}-a_{\alpha}, a^{*}-b_{\alpha}^{*}\right\rangle+\left\langle x^{*}, a_{\alpha}\right\rangle \quad(\text { by } 58) \text { and }\left(x^{* *}, x^{*}\right) \in \operatorname{gra}\left(A_{\circ}\right)^{*}\right) . \tag{59}
\end{align*}
$$

Taking the limit in (59) along with $a_{\alpha} \xrightarrow{\mathrm{w}^{*}} x^{* *}$ and $b_{\alpha}^{*} \rightarrow b^{*}$, we have

$$
\left\langle x^{* *}, x^{*}\right\rangle \geq 0 .
$$

Hence $\left(A_{\circ}\right)^{*}$ is monotone and thus (50) holds. Combining (50), Proposition 5.2(vi) and Theorem 4.1. we see that $A_{\circ}$ is of type (D).
'(ii) $\Rightarrow$ (iii) $\Rightarrow$ (iv) ': Apply Corollary 4.4 to $A_{\circ}$.
‘(iv) $\Rightarrow(\mathrm{v})$ ': By Fact 2.1d(iv) and Proposition 5.2)(ii), $A$ is maximally monotone. Then by Proposition 5.2)(vii) and Proposition 5.4((iii), we have

$$
\begin{equation*}
A^{*}=\left(A_{+}\right)^{*}+\left(A_{\circ}\right)^{*} \text { and } A_{+}=\partial \overline{q_{A}} \tag{60}
\end{equation*}
$$

Then $A_{+}$is of type (D) by Fact 1.2, and hence $\left(A_{+}\right)^{*}$ is monotone by Theorem 4.1. Thus, by the assumption and (60), we have $A^{*}$ is monotone.
‘(v) $\Rightarrow($ vi) ': By Proposition 3.2, $A$ is maximally monotone. Then by Fact 2.1d(vi) and Proposition 5.2(iii),

$$
\begin{equation*}
\operatorname{dom} A^{*}=\left(A^{*} 0\right)^{\perp} \tag{61}
\end{equation*}
$$

Then by Fact 2.1 and Fact 2.1 (iv),

$$
\begin{equation*}
\left[\operatorname{dom} A^{*}\right]_{\perp}=A^{*} 0 . \tag{62}
\end{equation*}
$$

Let $\left(x^{* *}, x^{*}\right) \in X^{* *} \times X^{*}$ be monotonically related to gra $A^{*}$. Because $\{0\} \times A^{*} 0 \subseteq$ gra $A^{*}$, we have $\inf \left\langle x^{* *}, x^{*}-A^{*} 0\right\rangle \geq 0$. Since $A^{*} 0$ is a subspace, $x^{* *} \in\left(A^{*} 0\right)^{\perp}$. Then by (61),

$$
\begin{equation*}
x^{* *} \in \operatorname{dom} A^{*} . \tag{63}
\end{equation*}
$$

Take $\left(x^{* *}, x_{0}^{* *}\right) \in \operatorname{gra} A^{*}$ and $\lambda>0$. For every $\left(a^{* *}, a^{*}\right) \in \operatorname{gra} A^{*}$, we have $\left(\lambda a^{* *}, \lambda a^{*}\right) \in \operatorname{gra} A^{*}$ and hence $\left(x^{* *}+\lambda a^{* *}, x_{0}^{*}+\lambda a^{*}\right) \in \operatorname{gra} A^{*}$ (since gra $A^{*}$ is a subspace). Thus

$$
\lambda\left\langle a^{* *}, x_{0}^{*}+\lambda a^{*}-x^{*}\right\rangle=\left\langle x^{* *}+\lambda a^{* *}-x^{* *}, x_{0}^{*}+\lambda a^{*}-x^{*}\right\rangle \geq 0 .
$$

Now divide by $\lambda$ to obtain $\lambda\left\langle a^{* *}, a^{*}\right\rangle \geq\left\langle a^{* *}, x^{*}-x_{0}^{*}\right\rangle$. Then let $\lambda \rightarrow 0^{+}$to see that $0 \geq$ $\sup \left\langle\operatorname{dom} A^{*}, x^{*}-x_{0}^{*}\right\rangle$. Thus, $x^{*}-x_{0}^{*} \in\left(\operatorname{dom} A^{*}\right)_{\perp}$. By $(62), x^{*} \in x_{0}^{*}+A^{*} 0 \subseteq A^{*} x^{* *}+A^{*} 0$. Then there exists $\left(0, z^{*}\right) \in \operatorname{gra} A^{*}$ such that $\left(x^{* *}, x^{*}-z^{*}\right) \in \operatorname{gra} A^{*}$. Since gra $A^{*}$ is s a subspace, $\left(x^{* *}, x^{*}\right)=\left(0, z^{*}\right)+\left(x^{* *}, x^{*}-z^{*}\right) \in \operatorname{gra} A^{*}$. Hence $A^{*}$ is maximally monotone with respect to $X^{* *} \times X^{*}$.

## ‘(vi) $\Rightarrow(\mathrm{i})$ ': Apply Proposition 3.2 directly.

The next three examples show the need for various of our auxiliary hypotheses.
Example 5.6 We cannot remove the condition that $A^{*} 0=A 0$ in Theorem 5.5)(iv), For example, suppose that $X=\mathbb{R}^{2}$ and set $e_{1}=(1,0), e_{2}=(0,1)$. We define $A: X \rightrightarrows X$ by

$$
\operatorname{gra} A=\operatorname{span}\left\{e_{1}\right\} \times\{0\} \text { so that } \operatorname{gra} A^{*}=X \times \operatorname{span}\left\{e_{2}\right\} .
$$

Then $A$ is monotone, $\operatorname{dom} A$ is closed, and gra $A$ is closed. Thus

$$
\begin{equation*}
\operatorname{gra} A_{\circ}=\operatorname{span}\left\{e_{1}\right\} \times \operatorname{span}\left\{e_{2}\right\} \tag{64}
\end{equation*}
$$

and so

$$
\operatorname{gra}\left(A_{\circ}\right)^{*}=\operatorname{span}\left\{e_{2}\right\} \times \operatorname{span}\left\{e_{1}\right\}
$$

Hence $\left(A_{\circ}\right)^{*}$ is monotone, but $A$ is not maximally monotone because gra $A \varsubsetneqq \operatorname{gra} N_{X}$.
Example 5.7 We cannot replace that "dom $A$ is closed" by that "dom $A$ is dense" in the statement of Theorem 5.5. For example, let $X, A$ be defined as in Example 3.4 and consider the operator $A^{*}$. Example 3.4(iii) \& (ii) state that $A^{*}$ is maximally monotone with dense domain; hence, gra $A^{*}$ is closed. Moreover, by Example 3.4|(i),

$$
\begin{equation*}
\left(A^{*}\right)_{\circ}=-A . \tag{65}
\end{equation*}
$$

Hence

$$
\begin{equation*}
\left[\left(A^{*}\right)_{\circ}\right]^{*}=-A^{*} . \tag{66}
\end{equation*}
$$

Thus $\left[\left(A^{*}\right)_{\circ}\right]^{*}$ is not monotone by Example $3.4 \mid$ (iii) even though $A^{*}$ is a classically maximally monotone and densely defined linear operator.

Example 5.8 We cannot remove the condition that $\left(A_{\circ}\right)^{*}$ is monotone in Theorem 5.5)(iv), For example, consider the Gossez operator $A$ (see [24] and [2]). It satisfies $X=\ell^{1}$, $\operatorname{dom} A=X$, $A_{\circ}=A, A 0=\{0\}=A^{*} 0$, yet $A^{*}$ is not monotone.

Remark 5.9 Let $A: X \rightrightarrows X^{*}$ be a maximally monotone linear relation.
(i) In general, $\left(A^{*}\right)_{\circ} \neq\left(A_{\circ}\right)^{*}$. To see that, let $X, A$ be as in Example 3.4 again. By Example 3.4|(i), we have

$$
\left(A^{*}\right)_{\circ}=-A \text { and }\left(A_{\circ}\right)^{*}=A^{*} .
$$

Hence $\left(A^{*}\right)_{\circ} \neq\left(A_{\circ}\right)^{*}$ by Example 3.4|(ii). Moreover, even when $A$ is a linear and continuous operator, one cannot deduce that $\left(A^{*}\right)_{\circ}=\left(A_{\circ}\right)^{*}$. Indeed, assume that $X$ and $A$ are as in Example 5.8. Then $\left(A^{*}\right)_{\circ}$ is skew and hence monotone; however, $\left(A_{\circ}\right)^{*}=A^{*}$ is not monotone.
(ii) However, if $X$ is finite-dimensional, we do have $\left(A^{*}\right)_{\circ}=\left(A_{\circ}\right)^{*}$. Indeed, by Fact 2.6 ,

$$
\left(A_{\circ}\right)^{*}=\left(\frac{A-A^{*}}{2}\right)^{*}=\frac{A^{*}-A^{* *}}{2}=\left(A^{*}\right)_{\circ} .
$$

We expect that $\left(A^{*}\right)_{\circ}=\left(A_{\circ}\right)^{*}$ for all maximally monotone linear relations if and only if $X$ is finite-dimensional.

The work in [5 suggests that in every nonreflexive Banach space there is a maximally monotone linear relation which is not of type (D).

When $A$ is linear and continuous, Theorem 5.5 can also be deduced from [2, Theorem 4.1]. When $X$ is reflexive and $\operatorname{dom} A$ is closed, Theorem 5.5 turns into the following refined version of Fact 2.9.

Corollary 5.10 (Monotonicity of the adjoint in reflexive space) Suppose that $X$ is reflexive and let $A: X \rightrightarrows X^{*}$ be a monotone linear relation such that gra $A$ is closed and $\operatorname{dom} A$ is closed. Then the following are equivalent.
(i) $A$ is maximally monotone.
(ii) $A^{*}$ is monotone.
(iii) $A^{*}$ is maximally monotone.
(iv) $A 0=A^{*} 0$.

Proof. "(i) $\Leftrightarrow$ (ii) $\Leftrightarrow$ (iii) $\Rightarrow$ (iv)": This follows from Theorem 5.5 and Fact 1.2 (ii).
"(iv) $\Rightarrow$ (i)": Fact 2.1प(iv) implies that $(\operatorname{dom} A)^{\perp}=A^{*} 0=A 0$. By Proposition 5.2(ii), $A$ is maximally monotone.

When $X$ is finite-dimensional, the closure assumptions in the previous result are automatically satisfied and we thus obtain the following:

Corollary 5.11 (Monotonicity of the adjoint in finite-dimensional space) Suppose that $X$ is finite-dimensional. Let $A: X \rightrightarrows X^{*}$ be a monotone linear relation. Then the following are equivalent.
(i) $A$ is maximally monotone.
(ii) $A^{*}$ is monotone.
(iii) $A^{*}$ is maximally monotone.
(iv) $A 0=A^{*} 0$.
